**MEMBERSHIP AS PARA-COUNSELLOR** - For those who have attained training at a Certificate level in counselling from a recognized Institution Fee: **Ushs. 75,000**.

- Copies of academic Transcript, Certificates and Originals for verification.
  - Valid identification - Card from your place of work/Institution.
  - Two passport photos - one for the file & the other for your ID.
  - Copy of membership payment receipt.
- B. MEMBERSHIP AS COUNSELLING/CLINICAL PSYCHOLOGIST:** These must be Qualified MSc./M.A holder in Counselling/Clinical Psychology.
- Copies of academic Transcript & Certificates & Originals for verification.
  - Valid Identification - Card from your place of Work/Institution.
  - Two passport photos - One for the file & the other for your I.D.
  - Copy of membership payment receipt.
- C. MEMBERSHIP AS COUNSELLOR:** These must be qualified Degree /Diploma holders in counselling.
- Copies of academic Transcript, Certificates and Originals for verification.
  - Valid Identification-Card from your place of Work/institution.
  - Two passport photos-One for the file and the other for your I.D.
  - Copy of membership payment receipt.
- D. MEMBERSHIP AS PARA-COUNSELLOR:** These must be qualified certificate holders in counselling.
